Statement of Investment Principles ("SIP")

#### Purpose of this Statement

This SIP has been prepared by the Trustees of The Malcolm Group Pension Scheme (1989) (the "Scheme"). This statement sets out the principles governing the Trustees' decisions to invest the assets of the Scheme.

The Trustees have consulted with the principal employer of the Scheme, Malcolm of Brookfield (Holdings) Limited (the "Company"), prior to finalising this Statement and have taken the Company's comments into account as appropriate.

#### 1. Governance

The Trustees of the Scheme make all major strategic decisions including, but not limited to, the Scheme's asset allocation and the appointment and termination of investment managers.

When making such decisions, and when appropriate, the Trustees take proper written advice. The Trustees' investment adviser, Isio Group Limited ("Isio"), are qualified by their ability in, and practical experience, of financial matters, and have the appropriate knowledge and experience.

Isio's remuneration may be a fixed fee or based on time worked, as negotiated by the Trustees in the interests of obtaining best value for the Scheme.

The Trustees review Isio's performance at least on an annual basis against a set of objectives, as specified and agreed by the Trustees. These objectives are shared with Isio, and the Trustees' views and comments are fed back to Isio as part of each formal review process.

#### 2. Investment objectives

The Trustees invest the assets of the Scheme with the aim of ensuring that all members' current and future benefits can be paid. The Scheme's funding position will be reviewed on an ongoing basis to assess the position relative to the funding target and whether the investment arrangements remain appropriate to the Scheme's circumstances. The Scheme's funding target is specified in the Statement of Funding Principles.

The Trustees' investment objective is to achieve a level of return above the return on a liability matching portfolio of UK Government bonds. The level of return the Trustees are currently targeting is specified in **Appendix A**.

In addition to the objective set out above, the Trustees look to:

- i) Maximise investment returns at an acceptable level of risk, as determined by the Trustees' risk appetite in the context of the Scheme's funding position and the strength of the Sponsoring Company's covenant; and
- ii) Ensure due regard is paid to the interests of the Company, in the size and incidence of contribution payments.

#### 3. Investment strategy

The Scheme's investment strategy was derived following careful consideration of the factors set out in **Appendix B** and the Trustees' investment objectives. The objectives have been taken into account at all stages of planning, implementation and monitoring of the investment strategy.

Details on the Scheme's investment arrangements are set out in Appendix A.

The Trustees take a holistic approach to considering and managing risks when formulating the Scheme's investment strategy.

The considerations include the nature and duration of the Scheme's liabilities, the risks of investing in the various asset classes, the implications of the strategy (under various scenarios) for the level of Company contributions required to fund the Scheme, and also the strength of the Company's covenant. The Trustees considered the merits of a range of asset classes.

The Trustees recognise that the investment strategy is subject to risks, in particular the risk of a mismatch between the performance of the assets and the calculated value of the liabilities. This risk is monitored by regularly assessing the funding position and the characteristics of the assets and liabilities. This risk is managed by investing in assets which are expected to perform in excess of the liabilities over the long term, and also by investing in a suitably diversified portfolio of assets with the aim of minimising (as far as possible) volatility relative to the liabilities.

The assets of the Scheme consist of pooled investments which are traded on regulated markets.

#### 4. Investment Management Arrangements

The Trustees have appointed a number of investment managers to manage the Scheme's assets as listed in **Appendix A**. The investment managers are regulated under the Financial Services and Markets Act 2000

All decisions about the day-to-day management of the assets have been delegated to the investment managers via a written agreement. The delegation includes decisions about:

- Selection, retention and realisation of investments, including taking into account all financially material considerations in making these decisions;
- The exercise of rights (including voting rights) attaching to the investments;
- Undertaking engagement activities with investee companies and other stakeholders, where appropriate.

The Trustees take investment managers' policies into account when selecting and monitoring managers. The Trustees also take into account the performance objectives the investment managers are evaluated on.

The investment managers are expected to exercise powers of investment delegated to them, with a view to following the principles contained within this statement, so far as is reasonably practicable.

As the Scheme's assets are invested in pooled vehicles, the custody of the holdings is arranged by the investment manager.

## 5. Liability hedging, leverage and collateral management

The Trustees have appointed Insight Investment Management ("Insight") to manage a liability hedging strategy, which aims to manage the Scheme's interest rate and inflation risk via a Liability Driven Investment ("LDI") mandate.

The Trustees adhere to all relevant regulatory guidance and requirements in relation to leverage and collateral management within the Scheme's LDI hedging strategy.

The Trustees recognise the need to hold sufficient liquid (i.e. daily dealt) mandates to support the LDI mandate, acknowledging that from time to time Insight may call capital on short notice to maintain the Trustees' target level of liability hedging.

The Trustees have agreed a collateral framework. Assets held within the immediate collateral framework with Insight are shown in bold, reflecting the lower governance burden on the Trustees due to automated collateral management.

The Trustees review this position on at least an annual basis to ensure there remains sufficient capital available for such purposes.

## 6. Investment Manager Monitoring and Engagement

The Trustees monitor and engage with the Scheme's investment managers and other stakeholders on a variety of issues. Below is a summary of the areas covered and how the Trustees seek to engage on these matters with investment managers.

Through the engagement described above, the Trustees will work with the investment managers to improve their alignment with the above policies. Where sufficient improvement is not observed, the Trustees will review the relevant investment manager's appointment and will consider terminating the arrangement.

The Trustees are aware of the importance of monitoring the investment managers' total costs and the impact these have on the value of the Scheme's assets. The Trustees also recognise there are other costs incurred by the investment managers that can increase the cost incurred by their investments.

Further details of the Trustees' investment management policies is set out in **Appendix C**.

#### 7. Employer-related and Direct investments

The policy of the Trustees is not to hold any employer-related investments as defined in the Pensions Act 1995 and the Occupational Pension Schemes (Investment) Regulations 2005 except where the Scheme invests in collective investment schemes that may hold employer-related investments. In this case, the total exposure to employer-related investments will not exceed 5% of the Scheme's total asset value.

#### Compliance

This Statement has been prepared in compliance with the Pensions Act 1995, the Pensions Act 2004, and the Occupational Pension Schemes (Investment) Regulations 2005. Before preparing or subsequently revising this Statement, the Trustees consulted the sponsoring company and took appropriate written advice. The Statement is reviewed at least every three years, and without delay after any significant change in the investment arrangements.

The Trustees confirm the information contained within this document reflects the Investment Strategy they have implemented for the Scheme.

The Trustees acknowledge it is their responsibility, with guidance from the relevant Advisers, to ensure the Scheme's assets are invested in line with these Principles.

The Trustees adopt an integrated risk management approach. The three key risks associated within this framework and how they are managed are stated below:
